## **JUDGMENT**

The Defendant was arraigned by the Prosecution on one count charge to wit;

"That you Idemudia (Alias King Alberto) sometimes in April 2018 in Abuja within the Judicial Division

of this Honourable Court attempted to commit cheating when you created a gmail account profile in the name of King Alberto, a male Caucasion with email <a href="kingalberto55@gmail.com">kingalberto55@gmail.com</a> and in that assumed character attempted to fraudulently induced one Linda Jones to deliver money to you and thereby committed an offence contrary to Section 320 of the Penal Code, Laws of the Federation (Abuja) 1990."

Upon arraignment the Defendant pleaded guilty base on the plea bargain parties entered.

The offence Defendant is charged with is non-capital offence. Same is one that Defendant can be convicted summarily upon plea of guilt. Consequently, Defendant having pleaded guilty to the one (1) count charge which is punishable under Section 320 of penal code, he is hereby convicted.

### **ALLOCUTUS**

I hereby sentence you to a term of one month in prison. Same shall be served in Suleja Prison,

Niger State. I hereby Order that the Iphone 6 used by the convict be and is hereby forfeited to the Federal Government of Nigeria.
